



1. Commission reviewed the number of fresh cases received, heard and disposed off. It was observed that in the data prepared, the cases heard at Raichur have not been included. Commission directed that the same may be got included and the data is corrected.
2. Commission noted that Karnataka Right to Information Rules 2005 have been amended to provide that a request for information shall relate to one subject matter only and it shall not ordinarily exceed 150 words. Commission also noted that this amendment came into effect from 17-3-08.
3. Annual Report in English version for 2005-06 is ready. The Kannada version of the report should also be ready by 11-4-08.
4. The work now has begun to compile the Annual Report for 2006-07. The entire work has to be over by end of May 2008. A meeting with the Public Authorities who have not provided the required information has been called on 19-5-08.
5. The first draft of the Annual Report for 2006-07 shall be prepared by Sri Srinivas and handed over to SCIC for scrutiny by 21-4-2008.
6. It was decided that the cases posted for hearing on 24-4-08 F.N. may be preponed from 11-30 to 10-30 in view of the fact that the Commissioners are proceeding to Bellary/Hubli by Air Deccan which is leaving at 1-30 p.m.
