



1. CONSTITUTION OF BENCHES FROM 1-8-2007: Circular was approved with minor modifications.

2. FILLING UP OF THE POST OF STENOGRAPHER IN PERSONAL ESTABLISHMENT OF DR. H. N. KRISHNA, SIC: Government has already sanctioned the posts. However, it has also stated that these posts are to be filled up by deputation. Since qualified candidates are not available to fill up these posts on deputation basis and the post of stenographer has to be filled up immediately for the SIC to function, it was decided to fill this post on out-sourcing basis, subject to subsequent ratification by the Government.

The Commission noted that the Government has already allowed filling up of the posts of two Judgment Writers on out-sourcing basis and the Stenographers posts being lower than the Judgment Writers posts, there should be no objection to fill-up such posts by out-sourcing.

3. PROGRESS IN DISPOSAL OF CASES: Commission noted that during the month of June, 218 new cases were registered, 435 were heard and 234 were disposed off. Thus, the disposal was more than the registration. However, out of 435 cases heard, only 234 could be disposed off. Commission also noted that number of cases pending for more than six months have increased from 41 last month to 50 this month.
