Uploading of Orders:

Commission reviewed the uploading of the orders and noted that the orders of the court halls have been uploaded to the KIC Server are as follows:

CH No.1: upto 1st October, 2010.

CH No.2: upto 22nd September, 2010.

CH No.3: upto 31st September, 2010.

CH No.4: upto 31st September, 2010.

It is also noted that the orders have been uploaded in the CGG server upto 26th August, 2010.

Therefore, Commission request the Secretary to speak to Smt. Padma Gola and others of the CGG and ensure that the first batch of the orders sent up to 17th and 25th September, 2010 are hosted immediately on the website of KIC.

Further, action should be taken to send the orders that have been hosted on the Commission's server to the CGG for hosting on the website of KIC.

Continuation of the staff working in CH.1 and CH.2:

Commission noted that the cases handled by Sri K.K. Misra, retired SCIC and Sri K. A. Thippeswamy, SIC have been adjourned to November, December, 2010; January and February, 2011.

Therefore, Commission decided that the respective Judgment Writers and other staff working in the office of the former SCIC, K. K. Misra and SIC, K. A. Thippeswamy should be continued till March 2011 in view of the pending work.

The correction of the previous data generated under GRR system.

It is noted that there are several cases where the status orders and disposal of the cases have not been captured in the website of the KIC due to the non-posting of the date of hearing, uploading of orders including posting of the all the cases decided by the four benches to bench A.

It is decided that Smt. Sangeetha would give the list of such cases where the benches have to be segregated and the correct date and order should be uploaded by the concerned judgment writer.

Judgment Writers are directed to ensure that the necessary correction is carried out with reference to bench segregation and also hosting of correct date and orders.

The defending writ petitions filed in the high court:

KIC earlier took a stand that being quasi judicial authority it may not contest the cases filed by way of writ Petitions/Writ Appeals challenging the orders passed by KIC.



Commission noted that the High Court in order in Writ Petition No. _____, have held that the KIC is a necessary party in the Writ Petition and Writ Appeal filed in Karnataka High Court and they should submit the relevant records.

However, in view of the above orders of the High Court it has become essential to file the para-wise remarks/objections in addition to producing relevant records.

Therefore, it is decided to write to the Advocate General suggesting him to instruct all the Government Advocates to take notices wherever the KIC has been made a necessary party in Writ Petition and Writ Appeal filed before the High Court including the circuit benches at Dharwad and Gulbarga at first instances and such notices.

Such notices may be sent to Sri Sharath Gowda, the Standing Council of Commission in the High Court to enable him to take necessary steps to defend the case.
