3. It was decided that tenders/ expression of interest may be called for preparation of Annual Report of the Commission and for providing system solutions for the Commission.

Additional staff for the Commission.


4. The proposal to appoint judgment writers and some supporting staff for the Commission is already with the Government. In the meantime, work in the section has increased. The Commission therefore decided that a retired official Sri Krishnoji Rao, Typist / Assistant should be appointed against the vacancy of a Personal Assistant by downgrading the post. A letter addressed to Principal Secretary to Government, DPAR (AR) intimating that this was being done in the interest of the Commission's work may be sent.

5. The proposal for regularization of reemployed officials in this commission is also pending with DPAR (AR) for a very long time. The regularization of these appointments is very necessary and should be done at the earliest.

6. In the meantime, the work of the Commission has been increasing. Last month the Commission received 114 number of Complaints and 37 Appeals and the existing staff is totally inadequate to meet the workload.


7. With addition of the latest proposal, following appointments of retired reemployed employees are pending for approval:
