Further, that there are about approximately 200 cases which have been heard by SCIC (KKM) in Court Hall No.1 and subsequently these cases have been adjourned for further hearing in the months of November, December, 2010 and January, 2011.

It is also noted that there are approximately 700 cases heard by SIC (KAT) in Court Hall No.2 and subsequently these cases have been adjourned to November, December, 2010 and January, February 2011. There are approximately 12,800/- complaints/petitions which are to be processed and petitions numbers have to be assigned before they are scheduled for hearing with a date.
